NOTICE is hereby given that the City Council of the City of Redlands, County of San Bernardino, State of California, will hold public hearings on the following:

- 1. Consideration of a Mitigated Negative Declaration in accordance with Section 15074 of the California Environmental Quality Act Guidelines.
- 2. **PUBLIC HEARING** to consider **Resolution No. 7849** (General Plan Amendment No. 137) to amend the General Plan land use designation of approximately 2.8 acres from Public Institutional to Commercial. The project is located at 212 Brookside Avenue and 216 Brookside Avenue at the northwest corner of Brookside Avenue and North Eureka Street (APNs: 0171-211-13-0000 through 0171-211-21-0000; 0171-211-25-0000; and 0171-101-01-0000 through 0171-101-05-0000).
- 3. **PUBLIC HEARING** to consider **Ordinance No. 2872** (**Zone Change No. 457**) to change the zone of approximately 2.65 acres from Administrative Professional (A-P) to General Commercial (C-3) District. The project is located at 212 Brookside Avenue and 216 Brookside Avenue at the northwest corner of Brookside Avenue and North Eureka Street (APNs: 0171-211-14-0000 through 0171-211-25-0000; 0171-211-25-0000; and 0171-101-01-0000 through 0171-101-05-0000).
- 4. **PUBLIC HEARING** to consider **Resolution No. 7850 (Demolition No. 281)** to demolish the former Redlands Safety Hall building totaling approximately 21,500 square-feet located at 212 Brookside Avenue (APNs: 0171-101-01-0000 through 0171-101-05-0000; 0171-211-17-0000; and 0171-211-25-0000).
- 5. **PUBLIC HEARING** to consider **Resolution No. 7851 (Demolition No. 282)** to demolish the former San Bernardino County Courthouse building totaling approximately 11,800 square-feet located at 216 Brookside Avenue (APNs: 0171-211-13-0000 through 0171-211-16-0000; and 0171-211-18-0000 through 0171-211-21-0000).
