NOTICE OF PUBLIC HEARING TO CONSIDER AN AMENDMENT TO THE ORDINANCE REGULATIONS OF FREEWAY-ORIENTED SIGNS AND TO CONSTRUCT A FREEWAY-ORIENTED SIGN EXCEEDING 120 SQUARE-FEET LOCATED AT THE SOUTHWEST CORNER OF WEST LUGONIA AVENUE AND CITRUS PLAZA DRIVE, ON THE WEST SIDE OF INTERSTATE 210 FREEWAY.

- 1. **PUBLIC HEARING** to consider **ORDINANCE NO. 2963** (ORDINANCE TEXT AMENDMENT NO. 368), an ordinance amending Title 15 (Sign Code) of the Redlands Municipal Code by updating Section 15.36.420 relating to regulations applicable to the location of freeway-oriented signs, by amending Figure 16 and adding additional property locations eligible for a freeway-oriented sign (around the Lugonia Avenue underpass at the I-210 freeway). This proposal qualifies for an exemption from environmental review in accordance with the California Environmental Quality Act Guidelines Section 15061(b)(3).
- 2. **PUBLIC HEARING** to consider **ORDINANCE NO. 2963** (SIGN CONDITIONAL USE PERMIT NO. 28), a request to construct a Freeway Oriented Sign for a motorist-serving business (drive-through restaurant) with an overall sign face exceeding 120 square-feet. The proposed sign is 95 feet high with a sign face consisting of 197.1 square-feet. The project site is located at the southwest corner of West Lugonia Avenue and Citrus Plaza Drive, on the west side of the Interstate 210 freeway, within the General Commercial (EV/CG) District of the East Valley Corridor Specific Plan (APNs: 0169-341-09-0000 and 0169-341-07-0000). The proposal qualifies for exemption from environmental review in accordance with the California Environmental Quality Act Guidelines Section 15311 for accessory structures such as on-premises signs. On March 12, 2024, the Planning Commission of the City of Redlands held a public hearing and recommended approval of the project to the City Council.
