

Redland's Plan to take on El Niño

The City of Redlands Flood Safety Plan (FSP) outlines planned responses to flood emergencies that negatively affect the city. (Such as an El Niño event)

The purpose of the plan is to provide information, policies, and procedures that will guide and assist the City of Redlands staff in efficiently dealing with flood emergencies such as an El Niño event. The plan addresses flood preparedness, notification process, flood fight, evacuation procedures, floodwater removal, and other related subjects. This plan allows implementation of the California Standardized Emergency Management System (SEMS) and will facilitate multi-agency and multi- jurisdictional coordination, among the City of Redlands, Special Districts, Counties and State agencies.



In the event of a large storm, the City may face a significant flooding threat. The existing flood control and storm drain infrastructure may be inadequate to handle more than a 13-year storm. A 100-year, 50-year or even 25-year storm event could overwhelm the existing infrastructure and send as much as 2-3 feet of water rushing through areas including downtown Redlands, University of

Redlands, and Redlands High School. At the end of 2012 and early 2013, at the direction of the City Council, City Staff, working with consultants, prepared the City's Flood Control Master Plan. Information on the plan can be found here: http://www.cityofredlands.org/qol/ disaster/flood



When Outside --

Avoid areas subject to sudden flooding. If you are caught outdoors during a heavy rain and flood climb to high ground and stay there.

- Stay back from rushing water, as during flash floods water can increase suddenly.
- If you come upon a flowing stream where water is above your ankles, STOP! Turn around and go another way.
- Don't walk through flooded areas. As little as six inches of moving water can knock you off your feet.
- Children should NEVER play around high water, storm drains, viaducts, or arroyos.
- Stay away from downed power lines and electrical wires. Electrocution is another major source of deaths in floods. Electric current passes easily through water.

Outside Your Home --

- Remember to help your neighbors who may require special assistance -- infants, elderly people, and people with disabilities.
- Before entering a building, inspect foundations for cracks or other damage. Do not go

in if there is any chance of the building collapsing.

- Be careful walking around. After a flood, steps and floors are often slippery with mud and covered with debris, including nails and broken glass.
- If your home, apartment or business has suffered damage, call the insurance company or agent who handles your flood insurance policy right away to file a claim.

Preparedness --

- . Take steps to reduce your risk of future
- Follow local building codes and ordinances when rebuilding.
- Use flood-resistant materials and techniques to protect yourself and your property from future flood damage.

Beginning in October of 2013, the City of Redlands began offering Community Emergency Response Team (CERT) training. Over the past two years, eight CERT classes have been offered, training more than 200 new CERT members. The CERT program educates participants about disaster preparedness for hazards, that may impact their area, and trains them in basic disaster response skills. They include fire safety, light search and rescue, team organization, and disaster medical operations. Using the training learned in the classroom and during exercises, CERT members can assist others in their neighborhood or workplace following an event when professional responders are not immediately available to assist.

Influenza Clinic

The City of Redlands, City Manager's Office, Fire and Police Departments, partnered with San Bernardino County Public Health department to provide a free flu shot clinic, hosted by Plymouth Village. Local citizens around the area were able to obtain a FREE Flu Shot or FluMist at their local community POD site. A Point of Dispensing (POD) site is a location where the community can go to receive medication and or vaccinations during a public health emergency, such as a pandemic influenza or bioterrorism.

These are the guidelines to follow in order to have received the vaccine:

Vaccine Guidelines

Adults: Men, women, senior citizens and pregnant women

Children: 3 years and older

- · A parent or guardian must accompany children under 18 years old
- · Children under 9 years old, may require two (2) doses of flu vaccine (4 weeks apart) based on prior vaccination history

· Healthy persons from 2 to 49 years



Hazard mitigation is defined by the Department of Homeland Security-Federal Emergency Management Agency (FEMA) as "any action taken to reduce or eliminate the long-term risk to human life and property from natural



A "hazard" is defined by FEMA as "any event or condition with the potential to cause fatalities, injuries, property damage, infrastructure damage, agricultural loss, environmental damage, business interruption, or other loss." We at the City of Redlands are very excited to have our revised Hazard Mitigation Plan of 2015 approved by the State of California, and the Federal Government.

The Great American "Shake Out"

The Great American "Shake Out" took place on October 15th, 2015 at 10:15 a.m. and was a nationwide activity. The purpose of the shake out was to inform and educate people about the potentials of earthquakes and earthquake damages. Being residents of California, this has become an increasing concern for most, for there has not been a major earthquake in California in about 20-30 years. It is because of this that we must better prepare ourselves so that in the event of the next major earthquake we may all be better prepared. Governor Jerry Brown explained







an earthquake. Also, the Redlands Emergency Communications group tested communications via ham radio at each evacuation site as well as Plymouth Village. Lastly, the City engaged with faith-based communities to enhance their emergency response protocol when contacting the city's Emergency Management.

2015 Grants and Awards Received

Since the beginning of the Emergency Management Program Fay Glass, Emergency Operations Manager, has been actively seeking grant funding for all the various projects and activities the department puts on. This year, there have been three major grants on the department's radar; Edison Public Safety and Preparedness Grant, Walmart Community Grant, and the Emergency Management Performance

Edison Donation: During the 2015 year, the Emergency Management Program received a generous donation from Southern California Edison (SCE) to be used for different Emergency Management projects. Southern California Edison is committed to helping the community be prepared for natural and human-caused disasters, and their support is focused on programs

that emphasize emergency preparedness and electrical safety. The Emergency Management Program received this donation and allocated half of the Program. The other half went to the Fire Department.

Walmart

Walmart Foundation Community grant program is operating globally and giving back locally. This grant was created to make an impact within the neighborhoods and provide local government agencies a platform to assist the community. The City of Redlands Emergency Management Program was awarded and has received this grant. The grant will provide logistical supplies and equipment to the Community Emergency Response Team (CERT) program.

Department of Homeland Security, Federal Emergency Management Agency (FEMA) Emergency Management Performance Grant

The purpose of the Emergency Management Performance Grant (EMPG) Program is to provide Federal grants to states to assist state, local, territorial, and tribal governments in preparing for all hazards, as authorized by the Robert T. Stafford Disaster Relief and Emergency Assistance Act (the Stafford Act); the City of Redlands was awarded this grant in the amount of \$19, 508.00. The grant will allow the Emergency Management program to hire a part-time/temporary staff to assist with the program. This upcoming year, 2016, the Emergency Management Program team, headed by Fay Glass, plans on applying for 16+ grants and is looking forward to some promising responses.

Emergency Notification System

The City of Redlands Emergency Notification System has been implemented in order to communicate emergency and other urgent messages to residents and community members within Redlands.

This system uses both text and voice messages to keep residents and community members of Redlands informed in case of emergencies that affect areas in which they live or work.

In the event of an emergency, residents and community members will receive a text with the latest information and safety instructions.

This System utilizes the area's 9-1-1 database, provided by the local telephone company and thus is able to contact land-line telephones whether listed or unlisted.
