<b>Obstructed Water Meter Resulting in an Estimated Read or Re-Read Trip Charge</b>	\$15.00
<b>Turn-off For Non-Payment of Municipal Services Account Charge</b>	\$46.00
<b>Broken Angle Meter Stop Charge</b>	\$75.00
<b>Broken Lock Charge</b>	\$15.00
<b>Remove Meter After Illegal Turn-On Charge</b>	\$50.00

<b>Cut Service at the Main Charge</b>	Time and Materials
<b>Submittal to Collection Agency Charge</b>	40% of Balance
<b>Return Check or Electronic/Automatic Debit Charge</b>	\$35.00
<b>Check-By-Phone Charge</b>	\$ 6.00
<b>Late Charge</b> – 10% of unpaid balance. Fee is calculated on each service component separately to arrive at a total charge.	
<b>Pre-Payment</b> – Shall be three times the cost of the estimated monthly service or \$70.00, whichever is greater. In the event your account is turned off for non-payment, a pre-payment may be required in order to re-establish your services. The pre-payment amount shall be applied as a credit to the applicant's account at the end of one year of satisfactory payment history (6 payments) or when the account is closed.
