2. CALL TO ORDER

The regular meeting of the Traffic and Parking Commission was called to order at 6:03 pm by Commissioner Curtis Dison.

3. APPROVAL OF MINUTES

The minutes of the regular meeting of May 2, 2022, were unanimously approved.

4. PUBLIC COMMENT

No non-agenda related public comments were made. Comments related to specific agenda items are incorporated into the item discussion.

5. COMMUNICATIONS

5A. *Status of Traffic and Parking Commission budget*

Ms. Silva presented a slide with an overview of expenditures relating to the Traffic and Parking Commission budget.

5B. *Status of work orders on items previously recommended by Commission and work orders on items approved by staff that fall within the existing Municipal Code not requiring Commission recommendation or City Council approval*

Ms. Silva presented a slide and provided a brief overview of the status of work orders that were previously recommended by the Commission and approved by City Council, and the status of work orders which do not require Commission recommendation and have been approved and completed by city staff in accordance with the Redlands Municipal Code.

5C. *Ridge Street Citizen Request Follow-up*

Mr. Harris presented an overview of the resident's traffic related concerns on Ridge Street, and detailed improvements and traffic studies performed on the corridor. Mr. Harris summarized the four speed studies performed in the area including a recent speed study performed at the apex of the sharp curve between Pacific Street and Center Street. The studies have not shown significant speeding, low traffic volume, and minimal truck traffic. There are currently no processes for a historic designation of a City Street and is unlikely to meet similar criteria apply to architectural and scenic resources. Mr. Harris explained that Ridge Street is not designated or proposed as a multiuse trail or bicycle route, however possible pavement markings that could be added is sharrows.

Ms. Silva read a public comment from Mr. Snow, resident, into record. Discussion ensued regarding combining No Trucks signs with a Truck Exclusion plaque to specify the maximum weight, width, or other restrictions in effect. Discussion ensued regarding tabling the item for the next commission meeting to allow the residents to attend and comment.

A motion was made by Commissioner MacDuff and seconded by Commissioner Dison to continue the item until the next commission meeting. The vote was 3-1 with Commissioner Tran against.

6. NEW BUSINESS

6A. *Approval of the request to establish a midblock crosswalk on Wabash Avenue between Sylvan Boulevard and Montecito Lane adjacent to Crafton Elementary School*

Ms. Silva presented Staff's recommendation of a midblock crosswalk on Wabash Avenue between Sylvan Boulevard and Montecito Lane adjacent to Crafton Elementary School. Discussion ensued regarding in-roadway pavements lights, school zone signs and a crossing guard assigned to the proposed location. **A motion was made to recommend to City Council the request to establish a midblock crosswalk on Wabash Avenue between Sylvan Boulevard and Montecito Lane**

adjacent to Crafton Elementary School. The vote was 4-0, the motion carried unanimously.

7. ADJOURNMENT

Discussion ensued regarding time limits on Commissioners when discussing agenda items. Commission reached a general consensus to discuss this topic when most of the commissioners are present.
