**3. SPECIAL PRESENTATION:**

*Recognition of Don Buchanan's years of faithful and diligent service on the Street Tree Committee – presentation of plaque* – Erik Reeves presented Don Buchanan a plaque from the City of Redlands and the Street Tree Committee for his unmatched service, along with a card. Janet Ward brought in treats in honor of Dr. Buchanan. A congratulations card was presented to Jocelyn Santa Cruz on the birth of her new baby.

**4. APPROVAL OF MINUTES:**

*Approval of Minutes for October 26, 2017* - Andy Hoder motioned for approval, Chuck Dykes seconded. Motion carried unanimously. (Chris Sedmack, Janet Ward, Chuck Dykes, Andy Hoder)

**5. STATUS REPORTS:**

A. *Bi-Monthly review of any new City parkway street trees in proposed developments* – Erik Reeves reported no new developments. Housing tracts on Northside, and NE Alabama/Park, industrial building, planting 12 trees mostly dryscape. Andy Hoder inquired about tree planting guidelines. Erik Reeves had sent tree planting guidelines to the Planning Department to take into account tree specifications. Erik Reeves is getting heads up so he could attend Planning Department meetings to check on city parkway tree plans.

B. *Bi-Monthly Street Tree Overview (QOL) – Update on City parkway trees trimmed, removed or planted* – Erik Reeves reported 27 tree removals, 27 trimmed locations and 3 emergency removals. Stump grinding machine is in the shop and will resume stump grinding schedule once repaired. Trimming schedule is going off the current list. See attached for non-emergency trimming, non-emergency dead tree removals and emergency tree removals.

**6. OLD BUSINESS:**

A. *Update from sub-committee tasked to look into assigning historical and landmark designations to street trees in coordination with the Historic & Scenic Preservation*

*Commission* – Janet Ward reported on contacting Sean McNaughton and Tom Ackley. (Tabled)

B. *Follow up discussion on list of trees that are in fair to good condition based on current inventory* – Erik Reeves contacted West Coast Arborist to discuss levels of tree conditions. Erik Reeves pulled report and rated declining/diseased parkway trees at 1700 locations on stressed trees due to various reasons, and sent report to Linda Richards. Erik Reeves to contact Carl Baker for the Facts article on the need to water stressed parkway trees; trees in City parkways belong to the City and to contact the Quality of Life if require information, in conjunction with article on the Triangle Tree Planting in April. (Tabled)

C. *Continue discussion on fall tree planting in cooperation with the Honorary Tree Program and Brookside Oak trees planting project* – Erik Reeves meeting with Jacinto Farming on Friday February 23 to discuss Brookside Oak tree planting project. Erik Reeves reported working with Shelli Stockton and West Coast Arborist to plant trees on list, 300-400 trees. Honorary Tree Program plantings will coincide with planting of Brookside Oaks and Triangle Park Oak tree dedication in April or May.

D. *Continue discussion on “Trimming Donation Program” to be added to the Street Tree Policy & Protection Guidelines Manual and the Redlands Street Tree Trimming Donation Program brochure* – Janet Ward working on brochure. (Tabled)

E. *Continue discussion on how surrounding Cities are handling utility pipes, overhead utilities and infrastructure as it pertains to tree roots, and branches* – Jocelynn Santa Cruz contacted cities of Riverside and Claremont, waiting on responses. (Tabled)

F. *Continue discussion and possible recommendation to Council on watering City parkway trees* – Erik Reeves reported that City is keeping current watering restrictions in place.

G. *Finalize discussion on Palm trees on Ford Street that are diseased, dying, or dead and need to be removed* – No action on removing diseased Palm trees on Ford Street at this time.

- *835 Tulane Court – Oak Tree* – Erik Reeves talked to the owner of the property who attended the STC meeting, to not intentionally damage or kill that Oak tree, that it is protected by the city and the Redlands Municipal Code. Erik Reeves to follow up. Janet Ward motioned to **not** remove Oak tree, to repair sidewalk with asphalt, and to move up trimming time. Chuck Dykes seconded. Motion carried unanimously. (Chris Sedmack, Janet Ward, Chuck Dykes, Andy Hoder).
- *13 N. San Mateo Street – Locust trees (2)* – Chuck Dykes motioned to **not** remove the 2 Locust trees due to no damage to sidewalks. Janet Ward seconded. Motion carried unanimously. (Chris Sedmack, Janet Ward, Chuck Dykes, Andy Hoder).

**2. PUBLIC COMMENTS:**

Resident Bettina McLeod noted that many trees that were planted on public school property have died due to inadequate care such as weed-whacking, mowing and over pruning, and suggested the STC discuss the issue with the District superintendent. Erik Reeves will follow-up on this and query about possibly posting 'water your tree' signs at the individual schools.

**3. APPROVAL OF MINUTES:**

*Approval of Minutes for October 26, 2017* – Janet Ward motioned for approval, Chuck Dykes seconded. Motion carried unanimously. (Chris Sedmack, Janet Ward, Chuck Dykes, Linda Richards, Paul Hodson)

**4. STATUS REPORTS:**

A. *Bi-Monthly review of any new City parkway street trees in proposed developments* – Erik Reeves reported no new developments.

B. *Bi-Monthly Street Tree Overview (QOL)* – Update on City parkway trees trimmed, removed or planted – Erik Reeves provided lists of removals and trimmed trees since the last week in February through April. See attached for non-emergency trimming, non-emergency dead tree removals and emergency tree removals. Reeves also said 190 trees will be planted citywide during the next two weeks where residents have agreed to water the trees, with more scheduled for planting in the fall, to total up to 300 trees. This was spurred by a request by City Councilwoman Toni Momberger. The Community Day of Service volunteer day this Saturday will include 56 trees on Fifth Avenue across from Moore, and 24 trees in Heritage Park.

**5. OLD BUSINESS:**

A. *Update from sub-committee tasked to look into assigning historical and landmark designations to street trees in coordination with the Historic & Scenic Preservation Commission* – Janet Ward introduced Tom Atchley from the Redlands Area Historical Society who agreed with STC's proposed heritage tree list. He also provided an overview of historical trees in Redlands. This began with the long history of peppers planted by Judson, and included the Eucalyptus tree in front of the high school on citrus as the city's oldest trees. He noted the blue palms planted on

Redlands Blvd dating to 1946, and the trees planted by the Judson and Brown's nurseryman in the 1880s, such as the two palms on Cypress by Gerards Market and the upper Eureka incense cedars. The camphor trees at Redlands University date from the 1920s on College Avenue through the 1950s, while some of the Washington palms planted by Eli Wade in the 1890s were sold for the cost of relocating by the citrus growers to the city of Loma Linda, where they still stand. Atchley noted three historic palms that died on Palm Avenue after over trimming by SCE. Atchley also noted the city's historical umbrella trees and encouraged establishing a street tree theme, such as the oak trees on Buena Vista, to provide street continuity. The Heritage/Landmark tree list will be submitted to the City Council for approval to be included into the Redlands City Municipal Code.

B. *Continue discussion of trees that are in fair to good condition based on current inventory* - In a follow-up of the declining/diseased parkway trees at 1700 locations, Erik Reeves discussed a plan where QOL, with Jocelynn Santa Cruz as contact person, will put trees that are reported as possibly drought-stressed due to a lack of watering will be put on an evaluation list, which will then be further assessed by Reeves or his crew. Residents of trees determined to be drought-stressed will be notified by Code Enforcement to water their tree, along with watering instructions. Reeves said late June to mid-July when the heat hits is an ideal time to determine drought-stress. Linda Richards checked with IERCD's Mandy Parkes who said they can donate a certain amount of soaker hoses to offer residents, and will follow up with her. (Tabled for more discussion at June meeting.)

C. *Continue discussion on "Trimming Donation Program" to be added to the Street Tree Policy & Protection Guidelines Manual and the Redlands Street Tree Trimming Donation Program brochure* – Janet Ward reported several improvements have been made to the brochure, which is close to being finished. (Tabled)

D. *Continue discussion on certificates for property owners/businesses for watering trees in front of their property* – Jocelyn Santa Cruz said Tim Sullivan is waiting to hear back from Carl Baker on this and whether it perhaps needs a resolution by the council.

E. *Finalize discussion on Arbor Day/Triangle Park tree dedication dates* – Erik Reeves reported the 2018 Redlands Arbor Day Celebration take place on May 18<sup>th</sup> at 5:30 pm.

**6. NEW BUSINESS:**

A. *Discuss dates for Water your Trees banner across Cajon/Citrus* – Linda Richards signed up for the following dates: Cajon July 9-15, Citrus July 20-29 and Prospect Park: Sep 3-16. Jocelynn Santa Cruz will confirm there will be no city fee.

**4. STATUS REPORTS:**

A. *Bi-monthly review of any new City parkway street trees in proposed developments* – Jocelyn Santa Cruz reported no new parkway trees for new developments.

B. *Bi-monthly Street Tree Overview (QOL) – Update on City parkway trees trimmed, removed, or planted* – Jocelyn Santa Cruz passed out list of trees removed, trimmed since the April 26 STC Meeting. See attached for non-emergency trimming, non-emergency dead tree removals and emergency tree removals. Andy Hoder asked about the procedures for Proposed Developments choosing Street Trees. Erik Reeves will follow-up. City working 2 days a week just doing stump grinding. City crew becoming more trained and working on city trees well. Erik Reeves contacted District School Superintendent on instructing their workers on better trimming of the schools in the Redlands District Parkway Trees and possibly posting “water your tree” signs at the individual schools. Also checking on Cope School replacing destroyed trees in Parkways on Cypress and Fern Avenue.

## 5. OLD BUSINESS:

A. *Update on status of seeking Council approval to add trees as Historical and Landmark designations in coordination with the Historic & Scenic Preservation Commission* – Jocelyn Santa Cruz reported Lauralee Farris, the Principle Planner and Staff Liaison for the Historic & Scenic Preservation Commission, will meet in early July and will vet the list. After that, it goes to CC for approval. Then included into the Redlands Muni Code.

B. *Continue discussion of trees that are in fair to good condition based on current inventory; possible subcommittee* – Linda Richards formed sub-committee consisting of Patty Mariano, Barbara Bates, Mandy Parks and Linda Richards, to identify drought stress trees throughout Redlands. Sub-committee will get with Jocelynn and Erik Reeves. Citizens could call in stressed trees to the QOL department. Previously, Erik Reeves discussed possible 1700 locations and a plan where QOL, with Jocelynn Santa Cruz as contact person, will put trees that are reported as possibly drought-stressed due to a lack of watering will be put on an evaluation list, which will then be further assessed by Reeves or his crew. Those determined to be drought-stressed will be notified by Code Enforcement, via calls or letters or in person, to water their tree, along with watering instructions. Reeves said late June to mid-July when the heat hits is an ideal time to determine drought-stress. Linda Richards checked with IERCD's Mandy Parkes who said they can donate 100 soaker hoses to offer residents. Linda Richards handed out flyer on trimming trees taking into account "Bird-Friendly Tree and Shrub Trimming" information to STC members. Jocelynn Santa Cruz reported that Erik Reeves is working up a GPS Program with a Map Overlay of the drought stressed trees submitted by the sub-committee.

C. *Continue discussion on “Trimming Donation Program” to be added to the Street Tree Policy & Protection Guidelines Manual and the Redlands Street Tree Trimming Donation Program brochure* – Janet Ward reported working and met with Jocelynn Santa Cruz finalizing the brochure, which is close to being finished. (Tabled)

D. *Continue discussion on certificates for property owners/businesses for watering trees in front of their property* – Jocelyn Santa Cruz said both types of certificates were sent to City Manager’s Office for approval. Jocelynn will get with Managers Office to provide feedback from STC on how homeowners/businesses will be submitted for certificates.

## 6. NEW BUSINESS:

### A. *Discussion and possible action on removal at the following locations:*

- *860 Denise Ave., Holly oak, resident claims roots are in the sewer line; maintenance issues* – Chuck Dykes motioned to have Holly Oak remain due to no outward signs of damage. Janet Ward seconded. Motion passed unanimously (Chris Sedmack, Janet Ward, Chuck Dykes, Linda Richards, Andy Hoder, and Barbara Bates). Tree will not be removed.
- *Frontier Communications Building, S. 4<sup>th</sup> St., Eucalyptus – tree produces debris on the rooftop, continual maintenance issues for the rooftop drains, leaves & sap are compromising the roof material. Corrective trimming is not an option as it would entail removing 7/8 of the existing tree canopy* – Janet Ward motioned to remove Eucalyptus citriodora tree and replant with a 24” – 36” box tree farther away from the Frontier Building, with the same species. Barbara Bates seconded. Motion passed unanimously (Chris Sedmack, Janet Ward, Chuck Dykes, Linda Richards, Andy Hoder, and Barbara Bates). Jocelyn Santa-Cruz checking on watering of 5 Crape Myrtles at this site. Tree will be removed by city crew within 30 days.
- *518 S. Buena Vista St., Coast live oak, tree stricken with ganoderma (root rot)* – Patty Mariano spoke on history of the Buena Vista Oak Tree Project and commented that herself and the property owner would like only a trim to be performed. Erik Reeves reported that ganoderma is a root rotting fungus and that the city did not feel comfortable with leaving the tree standing on site. He explained that due to the nature of the ailment as well as the potential hazard and liability, the City is making the decision to remove the existing Coast Live Oak tree. Erik Reeves also reported that he spoke with the owner several times and recommended the tree be removed due to it being unbalanced and diseased. City will remove the soil at that site and a new Engelmann oak, box tree, will be planted at the proper time. Erik Reeves checking on 2 other oaks on Buena Vista/Fern. Andy Hoder motioned to remove the Oak Tree, and surrounding dirt, and replant with a 24” box Engelmann oak. Chuck Dykes seconded. Motion passed unanimously (Chris Sedmack, Janet Ward, Chuck Dykes, Linda Richards, Andy Hoder, and Barbara Bates). The tree will be removed by city work crew within 30 days.

B. *Status on Incense cedar trees on Eureka, from Palm Ave to Fern Ave* – Erik Reeves reported 12 trees will be removed on Eureka from Palm to Fern Ave. In the fall, will be replanted probably with cedar trees.



- C. *Status on removal of diseased palms on Highland Ave and 5<sup>th</sup> Ave to be removed*  
– Diseased Palm on Highland Ave have been removed.
- D. *History of the Street Tree Committee* – Janet Ward reported on producing a report on the accomplishments of the Street Tree Committee from 2003 to the present. Gus Ortega will assist with report. Janet Ward will check into publishing of STC accomplishments in local newspapers.
- E. *Licensing of gardeners & all school gardeners* – Erik Reeves to get list of City licensed gardeners from Superintendent of Grounds. Janet Ward will research list of licensed gardeners in Redlands.
- F. *Send info to homeowners and businesses regarding: Don't water oak trees on the trucks, Water all street trees, Don't weed whack the trees, especially the Crape Myrtles* – Erik Reeves to check on contact information to re-insert tree information into City's Water Bills.

**3. STATUS REPORTS:**

A. *Bi-monthly review of any new City parkway street trees in proposed developments* – Erik Reeves reported KB Homes building on Lugonia Ave is ongoing but no planting yet.

B. ***Bi-monthly Street Tree Overview (QOL) – Update on City parkway trees trimmed, removed, or planted*** – Erik Reeves contacted District School Superintendent on instructing their workers on better trimming of the schools in the Redlands district parkway trees and possibly posting “water your tree” signs at the individual schools. Also checking on Cope School replacing destroyed trees in parkways on Cypress Ave and Fern Ave. Erik Reeves reported Palm trees from Redlands Blvd and Highland Ave to Fern Ave stressed due to possible over spraying of roundup. Erik Reeves reported on planting of 150 trees planted in Spring, city wide. 2 dead Palms on Cajon St are diseased; The Terrace is looking better due to additional water.

Center Street talked about several tree issues, one being a Chinese Pistache in the Franklin/Ford area on a truck route that needs trimming (his RV hits its branches) and a dead Oak tree on Ridge and Center that dropped a large branch, which Corrigan said has been scheduled for removal for a year. Chris Boatman promised removal in the next several weeks. Other concerning trees are Pepper trees on Elizabeth by Henrietta, and a large Eucalyptus branch hanging down on NE Palm and Cajon.
