<u>Public Comments</u> - Mayor Harrison called the special meeting of the City Council to order and provided an opportunity for the public to address them on the subjects which were scheduled on the agenda. There were no comments forthcoming.

Civic Center/Police Facility - Community Development Director Orci reviewed the various issues addressed by the Safety Hall Ad-Hoc Committee including the preparation of an interim relocation plan for the City Council review and development of a permanent solution related to the Safety Hall facility. The purpose of this workshop was to request direction from the City Council and community regarding the development of a new Civic Center or Safety Hall and consultant assistance. Solely based on the deteriorating market conditions coupled with the lower blended construction costs and the number of City assets, staff recommended the development of a Civic Center as well as soliciting "Requests for Proposals" for consultants to assist. Councilmembers discussed this matter at length. By consensus, with Councilmember Bean not agreeing with the majority of Councilmembers as he wanted the scope to be limited to issues surrounding only Safety Hall, the City Council directed staff to move forward with the "Requests for Proposals" and to look at a Civic Center and, if needed, narrow the scope to Safety Hall plus funds needed for maintenance of existing facilities and to get an opinion from the consultant as the best use of the parcel the Civic Center is currently located on as to what

would bring the City the most revenue. The Ad-Hoc Committee will continue to meet and bring forward its recommendations to the City Council.

Redlands Economic Development Plan - The City Council continued its review and discussion regarding the Economic Development Strategy Report first presented to the City Council on September 16, 2008, and again on October 21, 2008, and November 4, 2008. With Chief Information Officer Hexem recording Councilmembers' comments, Redevelopment and Economic Development Director Hobbs and Dr. John E. Husing, Economic & Politics, Inc. worked with Councilmembers as they reviewed the document. Jeff Sceranka addressed the City Council about marketing Redlands.

PUBLIC COMMENTS

<u>Amtrak Station</u> - Bill Cunningham informed Councilmembers the City of Loma Linda is applying for an Amtrak Station and felt the City of Redlands should indicate support for their application.
