- 2. Public Comments: Happy Holidays!
- 3. Approval of Minutes:
 - A. The minutes of the November 14, 2017 meeting was approved as written. M/S/P.

4. Status Reports:

- A. Packing House Report Roy provided the following updates:
 - 1. Overall, the market is down, but smaller oranges are up about a dollar.
 - 2. Compared to last year, #15 is higher.
 - 3. We are currently experiencing twice as much production.
- B. Farming Report- Chuck provided the following updates:
 - 1. The navel market is much better this year compared to last year.
 - 2. Irrigation watering still ongoing due to the lack of rain.
 - 3. City grove treatment is completed.
 - 4. Due to the warm weather, this might be one of the earliest harvests ever.
 - 5. Pre-emergent work will be completed just after the 1st of the New Year.

- 5. New Business:
 - A. Discussion pertaining to Newland Homes citrus grove transaction APN. 0168-161-07
 - 1. Site North of E. Lugonia Ave, East of Judson St (Lugonia Grove)
 - 2. The development consists of 9 acres for 105 homes adjacent to the grove, and developers need to meet open space requirements. Once the development is completed, Newland Homes will donate the grove back to CFD.
 - 3. Newland Homes want to use the grove as a contributor to the open space requirement and give City an easement to continue farming during entitlement acquisition.
 - 4. A meeting to verify if the grove meets open space requirements is taking place, as there is a concern about the legitimacy of the grove being considered open space
 - B. Citrus Fencing Updates:
 - 1. West Riverview and West Redlands Gateway groves are going out to bid.
