# CONSULTANTS AUTHORIZED TO PREPARE AND SUBMIT ENVIRONMENTAL TECHNICAL REPORTS

Updated: June 1, 2023

This list is made available to project applicants and prospective applicants for informational purposes only. It is the responsibility of prospective applicants to verify that the consultant they wish to hire is currently on the City's list and eligible to submit technical reports to the City. The City may reject reports prepared by unqualified consultants and/or consulting firms not currently identified on the City's list.

This list is NOT an endorsement or recommendation by the City of Redlands, nor does the City of Redlands or Development Services Department make representation or warranty of any kind, expressed or implied, of any consulting firm or individual's qualifications, ability, or capacity. The public is advised to conduct appropriate reference and background checks prior to engaging any firm or individual to verify that the firm or individual is qualified to perform the applicant's proposed scope of work and is in compliance with all applicable laws or regulations.

The following consulting firms may prepare and submit technical reports to the City for utilization in environmental review documents. Acceptance of a technical report or study does not guarantee that it is approved upon submittal; any necessary revisions to such reports (as determined by City staff and/or City's consultants) would be the responsibility of the applicant.

On July 24, 2017, the City Council adopted Resolution No. 7744 enabling applicants to prepare and submit up to three (3) environmental technical reports in support of their proposed project. Engineering technical reports are not included, and an unlimited number may be submitted (e.g., WQMP, geotechnical investigation, soils report, drainage/hydrology report, Phase 1 Environmental Site Assessment and Phase 2 site investigation for hazardous materials, etc.).

On May 1, 2018, the City Council adopted Resolution No. 7836 updating the City's environmental procedures for development projects. All projects that require the preparation of an Environmental Impact Report (EIR) must be contracted through the City, and all costs shall be the responsibility of the developer. Other major development projects that require an Initial Study to be prepared (i.e., Negative Declaration or Mitigated Negative Declaration) must have the environmental consultant contracted through the City and all costs shall be the responsibility of the developer. In addition to the direct cost for the environmental consultant, the Planning Division charges an additional 10% of the total contract cost for administration of the contract and reviewing work by the consultant, in accordance with the City's current Fee Resolution. After a development application has been submitted to the Planning Division, the assigned Planner will coordinate with the applicant and prepare the appropriate Funding Agreement for the project.

#### TRAFFIC IMPACT ANALYSIS, PARKING STUDIES, VEHICLE MILES TRAVELED (VMT) ANALYSIS

*Note:* Consultation between the lead agency (City of Redlands) and the consultant preparing the traffic study is recommended <u>prior to commencing work</u> on the study to establish the appropriate scope of work.

*VMT Analysis:* On July 21, 2020, City Council adopted local thresholds for VMT analysis and the "City of Redlands <u>CEQA Assessment VMT Analysis Guidelines</u>." Consultants should familiarize themselves with this document prior to beginning any work on VMT analysis in Redlands.

LOS Analysis: In addition to VMT analysis, the City may continue to require Level of Service analysis for purposes of evaluating a proposed project's compliance with the LOS standards in <u>Measure U</u> local growth management initiative (not included in the CEQA review process).

*Scope of Work:* Any studies prepared and submitted without a pre-authorized scope may be rejected, and additional work may be required by City staff or the City's peer review consultant. Traffic consultants should contact Mr. Don Young, Engineering Manager (909-798-7585, extension 6, or email 'dyoung@cityofredlands.org'), to discuss and agree upon the proposed scope of work in advance. For most projects, a written scope will be necessary.
