1. Call to Order: The meeting was called to order at 4:02 pm by Chairman Buoye.

  - A. Packing House Report:
    - 1. There was no report.
  - B. Farming Report- Chuck provided the following updates:
    - 1. Copper treatments were applied to the Mt. View property.
    - 2. The 5<sup>th</sup> Ave grove was pruned.
  - 3. Much of the grove activities are focused right now on watering, weed control, and gopher control.
    - 4. Admire was applied to the groves for ACP control. 4 treatments are planned this year.
  - C. Discussion and possible action to form a subcommittee to discuss the creation of standard

operating procedures for citrus planting plans:

- 1. Discussion was centered on concerns Chuck brought up at the last meeting.
- 2. It was decided by the Commission that a subcommittee would be a good idea. Andrew, Bob, and Jack will serve on the subcommittee. City staff will post the meeting.
- D. Discussion of Palmetto Grove funding distribution as it pertains to the Citrus Division presented by City Staff:
  - 1. The presentation was postponed to a later meeting date.

  - A. Discussion of possible land acquisitions:
  - 1. The Best property will be planted on 18' centers. Approximately 784 Orange trees will be planted on +/- 7 acres. Chain link will likely be needed on part of the property, as previously recommended by the CPC. The planting contract will be done using the City's online bidding system and it will be restricted to qualified farm management companies.
  - B. Project update on the West Riverview Citrus Grove planting plan and bid specification status:
  - 1. Approximately 601 Washington Navel trees will be planted on +/- 4.8 acres. Chain link fencing may be needed on part of the property, as previously recommended by the CPC.
