1. **CALL TO ORDER:** Chair Collins called the meeting to order at 4:33 p.m.
2. **PUBLIC COMMENTS:**
None forthcoming.
3. **APPROVAL OF MINUTES:** October 8, 2020 regular meeting minutes were approved with corrections by Commissioner Davis-Schultz, seconded by Commissioner Wells and carried.
4. **STATUS REPORTS:**
 - A. *City Council Liaison Report* – Council member Tejeda reported that the Project Backboard Murals were approved.
 - B. *FCS staff report on Park activities*- None Forthcoming
 - C. *FCS Staff Report* – on Recreational and Senior Activities
 - a. Dave Jaffe gave a brief presentation highlighting the virtual recreation classes and provided updates that Tennis, Cheerleading, and Yoga are allowed to return. Senior resource drive in took place at the Sports Complex, approximately 80 vehicles were treated with additional senior resource information and a goodie bag. Halloween Trunk or Treat took place at the Sports Complex serving 500 cars and approximately 1100 participants in a total of 3 hours. College applications are due at the end of the month so counselors are assisting with applications. Conditioning and practicing for sports are taking place but no games.
