SUBJECT:

Requested information regarding bike lockers for Parks and Recreation Facilities in the City of Redlands

DISCUSSION:

The Commission requested staff provide some information regarding bike lockers that could potentially be installed at the Community Center and/or Parks throughout town. Bike lockers are a more secure storage solution than traditional bike racks and detour the theft of units and auxiliary equipment installed on bikes.

Cost for bike locker units range from \$2500 - \$5000 dollars per unit and are available in single, double, and multi-unit configurations.
