Ratios & Groups	Number of students would be limited to the maximum occupancy / social distancing recommendations for the park area used. Minors under the age of 12 will be required to have one parent/guardian from the same household on site. Only one parent is allowed per child. Parents must social distance from each other in the specified parent viewing area while classes are in session.			Open at full capacity. Minors under the age of 12 will need to have only one parent/guardian from the same household on site. Social distancing will continue to be encouraged until the CDC recommends otherwise.	
Registration Procedures	All students must pre-register for classes online, or by phone. Once a class has reached its maximum capacity registration will close and additional students will not be added.			All students will be encouraged to pre-register for classes online, or by phone, in person registration at the Community Center will be allowed and all forms of payments will be accepted.	
Check-in / Check-out Procedures	Students, along with parents/guardians must wait outside of the park in their vehicles until a minimum of 10 minutes prior to their practice and the instructor is on site. City staff will check in class participants, asking all if they have displayed any symptoms in past 14 days, interacted with anyone who has or is suspected to have had COVID-19, and travelled internationally within the past 14 days. Students will be encouraged to utilize a sanitization station upon entering the facility and social distance during check-in by adhering to the markers on the ground. Staff will check-in each participant and their parent/guardian, perform a wellness check, and sign the participant in (no sharing of pens). After each class participants must use sanitization stations and leave the facility.			Everyone will be encouraged to utilize a sanitization station prior to the class and social distance during check-in by adhering to the markers on the floor. Parents/guardians and their children will be encouraged to arrive only a few minutes prior to class and when the instructor is on site. Staff will check-in each participant and their parent/guardian, and sign the participants in. Shared equipment such as pens should be sanitized after each use. After each class participants will be encouraged to use sanitization stations.	
Hygiene	Signage will be displayed encouraging hand washing/healthy practices. City staff will clean, and disinfect restrooms daily or more often if possible using EPA-registered disinfectants that are effective against SARS-CoV-2, the virus that causes COVID-19.				
Programming	Instructors will be encouraged to continue social distancing practices with students during sessions. Social distancing markers will be provided for each class participant to ensure 6ft of distance is maintained. Drills requiring partners will be suspended. Participants should bring their own supplies and equipment from home and will not be shared. Class structure will allow for 15 minutes for prep cleaning, and 15 minute after class clean up. Outside food and beverages (excluding water bottles) will not be allowed. Students must bring their own water bottles to class. Refillable bottles will be allowed to use the watering station for fill-up, however the shared drinking fountain will be closed for use by staff and the public.			Classes will resume their normal time frames and drills with partners will resume, though activities should encourage physical distancing until the CDC recommends otherwise. Shared supplies and equipment should be disinfected as needed, and when receiving heavy use. Outside food and beverages (excluding water bottles) will not be allowed in the center. Students must bring their own water bottles to class. Refillable bottles will be allowed to use the watering station for fill-up, however the shared drinking fountain will be closed for use by staff and the public until otherwise recommended by the CDC.	
Equipment	Students must bring their own equipment, items cannot be shared.	Shared equipment must be cleaned and sanitized after usage.			No Restrictions
Spectators	Parents/guardians and their children must wait outside of the park area in their vehicles until a minimum of 10 minutes prior to their class and the instructor is on site. Students under 17 may have one parent/guardian from their household unit with them during class. They may watch from a designated parent viewing area. Parents must bring their own seating. After each class participants must use sanitization stations and leave the facility. Bleachers and benches will not be available.			Spectators may view classes. Vulnerable populations should be asked to stay home.
